Kenya Tea Development Agency (H) Ltd intends to pre-qualify firms for **supply of approximately 88,665 metric tonnes of NPK 26:5:5 chemically compounded fertilizer** to smallholder tea farmers in Kenya for the year 2019.

This is a two stage procurement process whereby only technically pre-qualified bidders shall be called upon to submit financial bids in the second stage.

KTDA therefore invites manufacturers and/or their authorised agents to submit technical proposals for supply of the above fertilizer.

Interested eligible firms may obtain the prequalification documents from the procurement office, on first floor KTDA Farmers Building, Moi Avenue, Nairobi during normal working hours, upon payment of the registration fee.

Applications for prequalification should be submitted in sealed envelopes marked with the tender name and reference number addressed to:
