**To whom it may concern**

*On importation of products*

Additionally referring to the letter of SSUFSCP dated 22.11.2019 No 22-6/1/7806 we kindly inform on following.

Point 6 Article 55 of the Law of Ukraine “On the state control over compliance of legislation on food, feed, animal by-products, animal health and welfare” (No. 2042-VIII) (hereinafter referred to as – the Law), has determined that forms of international certificates are to be approved by the central executive body that ensures development and implementation of the state policy in the field of food safety and certain quality parameters, and in the field of veterinary medicine (note – Ministry of Economic Development, Trade and Agriculture of Ukraine, MEDTA), or to be agreed (negotiated) between competent authorities of Ukraine and exporting-country (country of origin).

MEDTA had developed the draft Order “On approval of the forms of international certificates”, that was published at the official MEDTA website in the relevant section “Documents”, available by the following weblink:

Taking into account the aforementioned, as well as in order to prevent the unjustified delays of imported food consignments into Ukraine, the decision on the special import requirements have been taken by the MEDTA, in particular that in case if there is no form of bilaterally agreed international certificate importation to the custom territory of Ukraine of products (food, feeds, by-products) is possible provided that consignment is accompanied by the form of international certificate that is published on the official website of MEDTA, until they will be approved by the relevant Ministerial Order.
