The owners of the "Chumak" brand are considering several settlements in the Odessa region for the construction of a new tomato processing plant.

This information is reported by "Bessarabia INFORM."

The most pressing concern for the manufacturer's representatives is the **establishment of tomato cultivation within** a **100 km radius of the future plant**, with a minimum of **1200 hectares**.

This prospect has caught the interest of farmers from the Kiliya territorial community. Additionally, experts from the Kiliya city council are preparing information about available land plots to be provided to the enterprise owners. According to the publication, "Chumak" will review all proposals over the course of several months. The construction of the plant is estimated to take at least two years. Moreover, after the de-occupation of Kahovka, the

owners plan to revive the enterprise there if feasible.



### Prices for Borscht Vegetable Set are at Their Lowest

The vegetable prices have reached their lowest point. This situation can be attributed, in part, to the amplification of information

regarding the anticipated shortage due to the losses suffered by the agricultural sector in Kherson region and the early vegetables."

Compared to the previous year, only beets and potatoes have remained relatively stable in price, while the rest have sharply declined. Onion prices have dropped to 14 UAH/kg on the wholesale market 'Shuvar,' down from 23 UAH last year. Carrots now cost 17 UAH, compared to 21 UAH previously. Beets are currently at 8.5 UAH/kg, down from 10, and potatoes are priced at 8 UAH, down from 8.2. This is according to Ivan Stefanyshyn, an advisor to the director of the agricultural product wholesale market 'Shuvar' in Lviv.

He also highlights an unusual situation with cabbage. In August 2022, the vegetable was priced at 22 UAH/kg, and today it's just 7 UAH. Many entrepreneurs also faced challenges with onions. Last year, there were high prices for onions during the winter-spring period, and some saw it as an opportunity for profit. They planted a lot, and the supply exceeded demand. The price per kilogram of onions dropped to 14 UAH, while the expectation was around 30 UAH. source...

# **Successful Season for Strawberry Producers**

Strawberry yield in Ukraine year was quite good. The amount of collected berries turned out to be even

larger than the spring predictions. Even though it was already the second season without berries from the occupied territories of the South, suppliers from other regions of Ukraine managed to meet the demand, <u>noted</u> Taras Bashtannik, the President of the Ukrainian Fruit and Vegetable Association.

The geography of strawberry cultivation is quite extensive: there are large plantations in Zakarpattia, Lviv, Volyn, Ternopil, Vinnytsia, Odesa, and Zhytomyr regions.

However, due to rainy weather in June, there were ongoing issues with the quality of the berries.

The average wholesale price for producers during the season was 40-50 hryvnias ( ${\in}1,0-1,25$ ) per kilogram. Berries harvested after the rain were approximately 20% cheaper. However, fortunate farmers who avoided the bad weather were able to sell their berries at a higher price, around 10% higher than the previous season, even slightly more. Farmers had concerns that the price would significantly drop during the peak of the season, but this didn't happen due to the substantial market capacity. Strawberries are well-known to consumers, anticipated, and loved, leading to quite active purchasing.



#### **Government Expands Opportunities for Processing Grant Program**

The Ukrainian government has expanded the opportunities of the grant program for the establishment of processing enterprises under the name "Processing". Soon, businesses that are registered, operational, or planning to start operations in the de-occupied territories will receive grants for the development of their processing enterprises. Additionally, a portion of the fees from grant recipients may be compensated from local budgets, as <a href="stated">stated</a> on the Ministry of Economy website.

### **German Investors Receive Extended State Guarantees for Operations in Ukraine**

The Federal Ministry of Economy of Germany has announced the expansion of the state investment guarantee program for German companies that decide to invest in Ukraine, where full-scale warfare is ongoing.

#### This is <u>reported</u> by the Ministry of Economy of the Federal Republic of Germany.

The investment program, now covers property losses and conversion and transfer risks, supporting German enterprises in Ukraine, and waiving the application fee until at least 2025. This expansion, backed by the National Bank of Ukraine and German authorities, bolsters economic collaboration. Currently benefiting 14 companies in Ukraine, the guarantees cover 280 million euros, excluding pending applications. This move not only supports Ukraine during these challenging times but also strengthens long-term economic recovery and bilateral cooperation between Germany and Ukraine.
